**Intended Use:** This solution is a Certified Reference Material (CRM) intended for use as a matrix modifier for graphite furnace atomic absorption spectroscopy (GFAA).

Certification & Traceability: Thermo Fisher Scientific is ISO 9001:2015 certified. This CRM was manufactured and certified by a Thermo Fisher Scientific supplier under an ISO 9001, ISO/IEC 17025, and ISO 17034 quality management system. This CRM was prepared to a nominal concentration of 100,000  $\mu$ g/mL by gravimetric methods using 98.7% pure ammonium phosphate (NH<sub>4</sub>H<sub>2</sub>PO<sub>4</sub>) dissolved in high purity nitric acid (HNO<sub>3</sub>) and diluted with filtered (0.22 $\mu$ m), 18 M-ohm deionized water. The balances used in the preparation of this CRM are calibrated regularly with traceability to NIST. All volumetric dilutions are performed in Class A calibrated glassware. The certified concentration was determined based upon gravimetric procedures. Secondary verification of the certified concentration was performed using ICP-OES that was calibrated and/or referenced against NIST SRM when available. The uncertainty associated with the certified concentration represents the expanded uncertainty at the 95% confidence level using a coverage factor of k=2.

**Uncertified Values:** ICP-MS was used to determine trace metal concentrations for this product (nd = not determined).

Instructions for Use: We recommend that the solution be thoroughly mixed by repeated shaking or swirling of the bottle immediately prior to use. To achieve the highest accuracy the analyst should: (1) use only pre-cleaned containers and transferware, (2) not pipette directly from the CRM's original container, (3) use a minimum sub-sample size of 500µL, (4) make dilutions using calibrated balances or certified volumetric class A flasks and pipettes, (5) dilute with the same matrix as the original CRM, and (6) never pour used product back into the original container. The solution should be kept tightly capped and stored under normal laboratory conditions. Do not freeze, heat, or expose to direct sunlight. Minimize exposure to moisture or high humidity.
