ASSAY: All test plates have CVs of less than 4%.

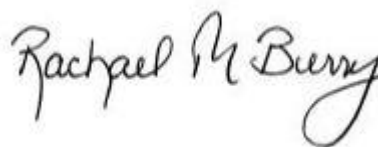
