Control Medium: Tryptone Soya Agar

A satisfactory result is represented by recovery of positive strains equal to or greater than 70% of the control medium from an inoculum of 10-100 colony-forming units (cfu). Negative strains are inhibited or shall produce at least a 1 log(10) reduction when compared to the control medium.

For *Pseudomonas aeruginosa* ATCC®9027, a satisfactory result is represented by recovery equal to or greater than 50% of the control medium from an inoculum of 10-100 cfu. For *Escherichia coli* ATCC®25922, a satisfactory result is represented by a negative diagnostic reaction from an inoculum of 1E+04 to 1E+06 cfu.
