**Antibody Preparation:** This antibody has been isolated from antisera by immunoaffinity chromatography using antigens coupled to agarose beads.

Form: Lyophilized

Antibody Concentration: 0.8 mg/ml after restoration

**Buffer Composition after Restoration:** 0.01 M sodium phosphate, 0.25 M NaCl, pH 7.6, 15 mg/ml bovine serum albumin

**Suggested Working Dilution Range:** 1:5,000-1:100,000 for enzyme immunoassays; 1:5,000-1:100,000 for western blotting; 1:500-1:5,000 for immunohistochemical staining

**Restoration and Storage:** Store product at 4°C until opened. Restore with 2.0 ml distilled water. Centrifuge product if it is not completely clear after standing for 1-2 hours at room temperature. To judge clarity, draw product into a pasteur pipette. After dilution, do not use for more than one day.

**Suggested Expiration:** One year from date of restoration, if extended shelf-life protocol is followed. To extend the shelf-life of this product, add an equal volume of glycerol to make a final concentration of approximately 50% glycerol and store at -20°C.

NOTE: The concentration of antibody and buffer salts will decrease to one-half of the original after the addition of glycerol.

**Antibody Specificity:** Based on immunoelectrophoresis, this antibody reacts with the heavy chains of rabbit IgG and with the light chains common to most rabbit immunoglobulins. No antibody was detected against non-immunoglobulin serum proteins. However, this antibody may cross-react with immunoglobulins from other species. This antibody may cross-react with SuperBlock<sup>®</sup> Blocking Buffers.
