The acceptance level for product is ≤ 0.10 EU/ml or ≤ 4 EU/device.

Volumetric Accuracy - Serological pipets are accurate to +/- 2% at full volume in compliance with ASTM E934, "Standard Specification for Serological Pipet, Disposable Plastic" and ISO 12771, "Plastics laboratory ware - Disposable serological pipettes".

<code>DNase/RNase Free</code> - Tested by nuclease assay method and found to be free of detectable <code>DNase/RNase</code> contamination. The assay detection limit is 10^{-7} Kunitz units/uL for <code>DNase</code> and 10^{-9} Kunitz units/uL for <code>RNase</code>.
